 - i. PRAP includes:
 - NYSDEC's proposed option to address contamination: utilize a new groundwater source located south of the village of Hoosick Falls and to treat water pumped from the source appropriately to

achieve drinking water standards and the cleanup action objectives described in the PRAP

- 2. Granular activated carbon filtration of the water is included in DEC's proposed option

 - i. Q: What is the nature of the health risk assessment at the McCaffrey site? A: All possible potential exposure pathways—soil, sediment, groundwater—are being looked at in terms of level of health risk.
 - ii. Q: Is NYSDEC involved in the construction activity currently going on at the old WCW factory?

A: No, the NYSDEC did not find any areas of concern during the site characterization. As a result, the site has new owners and any construction activity currently going on does not involve NYSDEC.

iii. Q: Does NYSDEC know when the next Water Quality Council meeting is scheduled for?

A: They are currently working on scheduling the next meeting and NYSDEC will let the CPWG know when it is scheduled.

- f. Public Comments/Questions
 - i. Q: Are POETs being addressed in the PRAP?

A: The PRAP is specific to the municipal water supply. Short- and longterm solutions for private well owners will be addressed under another operable unit, OU 3.

III. Other Hoosick Area CPWG Business

- a. Ongoing Action Items Status, Discussion, and NYSDEC Response
 - i. Air emissions: Status of CPWG's request for more testing and the development of a proactive approach to minimize potential for future exposures going forward
 - 1. CPWG has proposed a joint meeting of NYSDEC, NYSDOH, EPA, and CPWG Co-chairs
 - ii. Concerns of property owners with wells: POET maintenance and POET eligibility
 - 1. NYSDEC will continue to maintain POETs and offer POETs to town residents

- 2. NYSDEC will also:
 - a. Include information on how DEC will be addressing POETs at the PRAP public meeting on 5/13/21
 - b. Provide the town with POET information that they can share with residents
 - c. Coordinate with the town to host a future POET public information meeting
- iii. Potential impact of Saint-Gobain whistleblower on current remediation activities <u>Saint-Gobain whistleblower says company ignored pleas to</u> probe pollution sites
 - 1. Since NYSDEC's remediation plans are based on existing data, the allegations do not affect the NYSDEC's remediation approach
 - 2. NYSDEC's legal counsel will continue to monitor the situation
- iv. Status of adding PTFE to the TRI:
 - 1. NYSDEC's current position:
 - a. PTFE is made up of other compounds that are currently on the TRI
 - b. PTFE does not meet the criteria to be added to the TRI
 - 2. NYSDEC will meet with CPWG Co-chairs to provide additional information
- v. GAC systems: Effectiveness of additional filters
 - a. Mayor Allen to share data with CPWG and post recent data on the village website
- b. Other national and NYS activities relevant to Hoosick Falls
 - i. CPWG Communication Activities
 - 1. Co-chair Brian Bushner has drafted letter to EANY to correct misinformation about current water quality versus quality of source water
 - a. Co-chairs will share with full CPWG for comments prior to sending
